
James W. Hosking - 600 Dewey Avenue - 1843 home

Limited information can be found about James Hosking in the local newspapers. There are several possible articles that could be pertaining to him or his family, but some are under the last name of Hoskins, instead of Hosking. In fact, when his wife passed away, she was listed as Rebecca Hoskins. Their graves are next to each other with his listing the last name as Hosking and hers listing the last name as Hoskins. It is also difficult to determine children's names as some are mentioned under both names.

There are other families in the Galena area with the last names of Hosking or Hoskins, but it was too difficult to determine if they were related to James Hosking or not.

The newspaper articles included here may or may not be the same James Hosking or his immediate family, but they are included as possibilities.



Galena Daily Courier – September 17, 1859 – suicide attempt – not sure if this was him

On the evening of the 11th inst., Mr. Jas. Hoskins, having become tired of this world's cares, made an attempt to put an end to his existence by hanging. He was discovered and cut down in time to prevent the full accomplishment of his design.

Galena Daily Courier – August 2, 1860 – death/funeral (date matches the grave headstone even though the last name is given as Hoskins).

Death of an Old Citizen.

Mr. James W. Hoskins, one of our oldest and most respected citizens, died in this city yesterday, the 1st inst. He was eighty years of age, and he had been a resident of this city tor over fifteen years. His funeral took place this afternoon, from the Bench Street M. E. Church, of which he has long been a prominent and most exemplary member.

Galena Daily Advertiser - August 2, 1860 - death/funeral

Beath of James W. Hoskins.

Our old citizens are, one by one, departing-Yesterday, we were called upon in the order of events, to notice the death of D'Arcy A. Farson, aged 70 years. Today, we sorrow deeply at the departure of another of still greater age, and whose friendly intimacy we long shared.

On August 1st, 1860, died in this city, JAMES W. HOSKINS, at the age of 80 years. He was born in the county of Cornwall, Eng. land, January 10th, 1780. From time he was 15 years of age till he came to this city in 1832 he followed the sea for most of the time trading between England and the East and West Indies. A part of the time, however, if we are not mistaken, he was engaged in the silver mines of South America. Wherever the lot of our departed friend was cast, we venture to affirm that he met all the requirements of a noble manhood. He was as true to himself, to his country and to his God as most men get to be in this world of trinl; and he laid down his life calmly and without fear, like a true Christian, when life's long voyage was over: Peace to the ashes of a just and upright man, whose natural courage, and modest bearing, and independent spirit, and bumble trust in the guidance of a wiser hand than that of man, will long be remembered with veneration by all who knew him well, Forty-eight years ago he received the doctrines of christianity by experimental faith; fourteen years ago he united with the Methodist Episcopal Church in this city, of which he died a member.

The Funeral will take place from the Bench Street M. E. Church, this afternoon, at 2 2 o'clock. Friends and acquaintances are nvited to attend.

Galena Daily Gazette - March 15, 1884 - death/funeral of wife

Mrs. Rebecca Hoskins diedat her residence on Broadway, in this city, last evening, at the advanced age of 89 years. Deceased came to America from the County of Cornwall, England, in 1839, and was one of the early settlers of Galena. Her husband, Mr. James Hoskins, died here in 1860. The funeral will take place from the First M. E. Church tomorrow (Sunday), at 4 o'clock P. M. Friends of the family are invited to attend.

Galena Daily Gazette - September 8, 1884 - daughter's death?

Mrs. Mary Bailey, formerly of this neighborhood, and a daughter of the late James Hosking, died of paralysis at her home in Sonora, California, Aug. 27. She was an estimable lady. Her brother J. L. Hosking, resides at Sonora.

Galena Daily Gazette - February 14, 1884 - son's death?

We have received a notice of the death of Mr. John J. Hosking, at Sonora, California. The funeral occurred January 19. The deceased formerly resided in this vicinity and was a son of the late James Hosking.





Miscellaneous Information:

James W. Hosking was born around 1779 in Helston, Cornwall, England.

James died on August 1, 1860, in Galena, Illinois and is buried in Greenwood Cemetery. He was 80 years, 8 months, and 21 days of age according to the headstone.

James emigrated from England around 1832 with his wife.

His wife was Rebecca Tonkin Hosking. She was born in 1803 in England.

Rebecca died on March 16, 1884, in Galena, Illinois and is buried next to her husband in Greenwood Cemetery.

James and Rebecca may have had a few children, but not much information can be found. Based on the articles above, it looks as if there was a son named Charles, but no information is available.

Two other children listed (articles are above) are John and Mary who appear to have lived in California. In the census listing, there is mention of a daughter Jane Gill, who was married to John Gill. No further information was found on Jane Gill.

Subsequent Ownership:

Since there is not much information to find on James Hosking, additional research was completed on the next owner, listed as George Edwards (purchased around 1884). Since Edwards was a common name in the area, it was difficult to determine for sure which newspaper articles pertained to this specific George Edwards but based on the content of the articles those believed to be about this person (to the best of our knowledge) are included in this document. There appears to have been two men named George Edwards living in Galena around the same time, so we had to speculate as to which ones were about the man we were researching.

Articles on George Edwards – second house owner Galena Daily Gazette - June 25, 1874 – brother's injury

Charles Edwards, thirteen years old, brother of Mr. George Edwards, at the upper end of the city, had his finger's caught in the machinery at Mr. Westwick's foundery, a few days ago, and quite badly hurt. The end of the middle finger was completely torn off.

Galena Daily Gazette – March 27, 1879 – property purchase from grandmother

Whitham, Ann to George R. Edwards, March 18, 1879; undivided q of lt 10, blk 1, lts 1 and 11 in blk 2, lt 10 in blk 5, etc., in Young's Add to Galena; lts 12 and 13, Broadway, etc.

Galena Daily Gazette - May 26, 1879 - sister's death

Mrs. Selina Newcomer, formerly Miss Selina Edwards, of Galena, died at Washington D. C. May 20, 1879, aged 26 years and 11 months. At the time of her death she was visiting relatives in Washington. She was a sister of George R. and Charles Edwards of this city. An excellent lady is cut off in the bloom of young womanhood.

The three brick houses on Bench street belonging to the Bradner Smith estate were sold at auction this afternoon, Robert Brand crying the sale. There were a number of bidders and the property brought good prices.

The Smith homestead at the corner of Hill street, now occupied by A. J. Louchheim, was sold to John Cloran, Jr., the price being \$2,600.

Judge Hodson bought the upper of the two brick houses adjoining each other, the price being \$1,505.

The third house was not sold at auction, but immediately after it was bought by George R Edwards for \$1,000.

Galena Daily Gazette - December 8, 1891 - house repairs

Galena Daily Gazette - May 17, 1892 - house rental

W. H. Blewett has moved into the house on Bench street which was recently purchased by George Edwards.

Galena Daily Gazette - February 27, 1893 - runaway horse damage

Three young men from Council Hill came to town Sunday evening in a cutter. While driving up Bench street their team became unmanageable and ran away, throwing out the occupants of the cutter near Turner Hall. The runaway collided with William Kloth's building at the cor-

ner of Broadway and then dashed into the front of George Edwards' residence across the street, damaging a window. They continued their flight until near the Zins place north of town, where they were captured.

Galena Daily Gazette - July 7, 1893 - property sale

George R. Edwards has sold to the Misses Sarah E. and Lizzle K. Virtue, of Rawlins, a lot on Broadway adjacent to Whitham row. A house will be erected thereon this season and the two ladies and their mother will come to Galena to live.

Galena Daily Gazette - August 7, 1893 - house upgrades

George R. Edwards has about completed the extensive improvements on the Whitham row on Broadway, which were begun last month. He has now let the contract for bath-room, and complete water systems in all the houses. This extensive contract has been taken by C. A. Asmus.

Galena Daily Gazette - August 8, 1893 - horse complaint

George R. Edwards complained on Joseph Hans, the milkman, for allowing his horse to stand untied in the public street. The case was brought before Justice Ryan and Mr. Hans acknowledged the truth of the charge and paid a fine of \$5. Mr. Edwards also picked up two horses which were running loose on his property, stabled them, and required the owners to pay the cost.

Galena Daily Gazette - October 3, 1893 - house upgrades

George R. Edwards has now about completed the extensive improvements on the Whitham row which were begun early in the summer. The houses are practically new now and come nearer the modern idea than the general run of rented houses in the city.

Galena Daily Gazette - May 1, 1894 - cow complaint

George R. Edwards is continuing his crusade against violators of the cow laws. Complaints have been sworn out by him against five citizens of the upper end of town whose cows have been at large, regardless of the law. One of the defendants settled and the other cases are to come before Justice Ryan. Mr. Edwards is determined to protect laws and lawns against the intrusion of Queen Cow to such extent as he is able.

Galena Daily Gazette - February 28, 1895 - house fire

AN INCIPIENT BLAZE.

Residence of George R. Edwards Has a Narrow Escape.

The residence of George R. Edwards at the corner of Broadway and Meeker street was seriously damaged by a fire early this morning and had a narrow escape from total destruction. The building is a one-story frame, with basement, and has a two-story addition in the rear, which is occupied by other tenants. The only inmates of the main part of the house last night were George and Charles Edwards, their mother being at Warren on a visit to friends.

At 3:30 o'clock in the morning Charles Edwards was awakened by the smell of smoke, and he found the house full of smoke, while a fire crackled and burned in the attic overhead. An alarm was turned in at the No. 3 fire-house and the Leadmine hose company responded promptly and soon had the fire under control. The walls and ceilings were badly damaged by fire and water, and the loss will amount probably to \$200. It is fully covered by insurance in the Continental. The fire was caused by a defective flue.

WORK OF INCENDIARIES

AN OLD LANDMARK IS IN RUINS

The Second Fire in a Week in the Property of George R. Edwards.

A fire just after midnight this morning, which was beyond reasonable doubt the work of incendiaries, reduced to ruins one of the landmarks of Meeker street, the old building belonging to George R. Edwards which stood at the west end of the small bridge across Hughlett's branch. It has had many uses in its day, but was last occupied as a barn by John Palmer. Mr. Edwards owns a block of property bounded on two sides by Meeker street and Broadway, and including fifteen dwelling houses and the building destroyed. The fact that this was the second fire to occur in a week in the block confirms the suspicion of incendiarism.

The fire was detected and the alarm turned in from No. 3 fire station at 12:30 o'clock. The Leadmine hose company made such prompt response that although the building was of wood throughout, dry as tinder and the second floor filled with hay, it was partially saved and the four burned walls are still standing. The butlding was insured for \$200 in the Continental. Mr Palmer lost the hay stored in the loft and a few small implements and miscellaneous articles.

Galena Daily Gazette - March 8, 1895 - second house fire (contd)

Fire Marshal Grady had a narrow escape from lajury during the progress of the fire. He was forcing the front doors open when a heavy board fell from the top of the building and struck him on the side of the head with sufficient force to knock him down. The Liberty Hook and Ladder company reported for duty but was not brought into requisition.

The fire was soon subdued, and as is believed, was thoroughly quenched. But at 3:30 o'clock a fresh blaze was discovered in the northwest corner, which had previously escaped. No alarm was given but the Leadmine boys were called out again and soon put out the blaze.

Just a week before, at 3 o'clock Friday morning, the dwelling occupied by Mr. Edwards was discovered to be on fire. The blaze was controlled, but not until damage to the extent of \$200 had been done. It was surmised then that incendiaries had been at work but no overt charge was made. In this case, however, there was no stove or light in the building and it is palpable that the fire was deliberately set.

One theory advanced and one which Mr. Edwards thinks plausible, is that some one whose enmity he incurred through his enforcement of the cattle laws may have committed the despicable crimes. He was one of the few who had the moral courage to attempt to enforce the laws for keeping cattle inclosed and was instrumental in securing several convictions. Of course the connection of the two circumstances is merely suggested, without any evidence to point to any individual as the perpetrator of the helnous crime of firing a dwelling at night. The only ground for the theory is that Mr. Edwards knows of no other enemies, and the deeds were certainly the work of an enemy.



George R. Edwards was born around 1840 and remained single.

His occupation was listed as a school teacher.

It is believed that he passed away on April 22, 1914, but could not find an obituary or information on where he is buried.

He lived most of his life in Galena with his grandmother (Ann Whitham), his mother Salina Edwards, and his brother Charles (CW), who may have moved to Chicago later in life.

His sister Salina passed away when she was only 26 years old.

According to some of the articles, he may also have had a brother John A. of Dakota and another sister, Mrs. P.T. Stevens of Wisconsin.

The census reports also list other family members/children but could not find anything more on them. In one census listing, his "inferred" father is listed as John Edwards, who may have passed away young.

Nothing was found in find a grave, but there was mention of George Edwards who passed away in 1914, but it was a military plaque. There had been no prior mention of his being in the military, so it was not included.
